Committee Reports

GV Community Coordinating Council

There were a few things of specific interest to EE residents at this month's meeting. The most important of these is that the Fire Corps will change the batteries in your smoke detectors and during the same visit conduct a safety check of your home. Of interest is that from July 1 through September 15, there were 216 incidents of falling in Green Valley homes; of these, 125 required transport to the hospital. Considering that our winter residents were absent that seems to be a very large number. We aren't getting any more agile. The Continental underpass was declared to be complete as of the first week of November. I suppose those were ghost trucks that held me up this morning. The median work being done by AAA Landscaping is a once per year project and looks good.

What is the GVCCC & why should you care?

The GVCCC is important to all of us in Green Valley. Specifically, it provides a resource for all citizens to take issues to a "higher authority."

Green Valley has been recognized by Pima County as a year-round residential area since 1964 and, like Topsy, "We just growed." In 1973 the Green Valley Community Coordinating Committee (now referred to as the Council) was formed as a 501(c) (4) corporation. The Council has no legal authority, but exists as a conduit to governmental agencies at the county and state levels. GVCCC consists of over 70 Homeowners Association members with a slate of officers and nine standing committees. Each of these committees has a contact in government.

There are six officers: President, First Vice President, Second Vice President, Secretary, Treasurer and Parliamentarian. In addition, there is an Executive Director and Support Staff. There

are three employees; everything else is a volunteer effort.



GVCCC is the "focused advocate" of the citizens of Green Valley. The Council administrates the activities of the standing committees. They are as follows:

- Architectural Review: Reviews the future property use in Green Valley. The County uses this committee to review all Planning, Zoning and Design issues and recognizes the recommendations of the committee.
- By-Laws
- Community Services: Provides initiatives guidance and coordination not specifically covered by other committees. Examples of this committee's activities include the Dispose-A-Med Program and the Good Hands Program, which maintains a list of minor unlicensed contractors for the community.
- Citizens Corps: Provides liaison with the area's first responders.
- Environmental: All environmental issues.
- Government Liaison
- Health and Human Resources: Works with medical and health-related services as well as human services providers to assure continuing availability of those services.
- Membership: Works to develop new memberships.
- Nominating: At the president's direction develops a slate of candidates for GVCCC offices.
- Personnel
- Public Utilities: Monitors local utilities to ensure that water, electric, gas, telephone and sewage services are provided at a reasonable rate.
- Traffic and Arroyos: My favorite committee. They are the pot hole and sidewalk committee and I visit them monthly. I am known as the squeaky wheel.

• Transit: Formed in 1998 to bring transit services to Green Valley. Working with the Regional Transit Authority brought bus services here in 2009.

GVCCC seems to have a committee for everything. These committees exist to assist us in presenting our problems to a higher level. They can't solve all of our problems, but they can open more doors than we can individually. An example is the condition of our streets, which is deplorable. We need our streets rebuilt, but it ain't going to happen. So we take our street problems in smaller doses that the County will address.

My personal assessment is that GVCCC could be our ombudsman, but we all need to force the issue. If we have a problem that we (the HOA Board) can define in a way that will evoke action from one of the standing committees we can force the GVCCC to act for us. Supervisor Carroll attends the monthly GVCCC meetings. Senator Kyle opens his office on the day of GVCCC meetings as does Representative Giffords. GVCCC can't solve all our problems, but if we don't bring them forth, nothing will ever get done.

Common Areas

The weeds which have been the subject of this column for the past couple of months are starting to fade a bit as an issue, as they are pretty much now under control. From now on, the landscape maintenance crew will be working on other matters, the most regular of which will be trimming back our Bird of Paradise plants for the winter. To look their best, these plants need to be trimmed down to about a foot or so in height so they will come back and grow well next spring. We have a ton of this species in Esperanza Estates, and they will keep the crews busy.

We are using a new mapping system to direct the landscapers to the areas in EE needing attention. This is done by photocopying a map of the subdivision, and providing it to the crew each week with appropriate notes and directions on it, showing exactly where they should concentrate their efforts. This has worked pretty well so far.

On Wednesday, December 8, right after Free Coffee and Donuts at the Ramada, we will have a work party for volunteers who might want to help us somewhat in the common areas. Bring gloves and clippers if you have them, and we will do a little work helping to beautify our neighborhood. No commitment is required--work as much or as little as you feel up to. But remember, an hour or so with a few volunteers can make a big difference in our subdivision's appearance. This work by volunteers enables us to use the landscape crew for other tasks, and helps keep us ahead of the game.

CSI: Alaska

Esperanza Estates resident
Sam Barnard doesn't read
crime fiction or watch
police shows on TV. He doesn't need to. His
20-year career as an Alaska State Trooper
provided plenty of first hand experience with
crime investigation.

After serving in the Navy, Sam moved to Alaska at the age of 21 because it offered opportunities. "I thought it was a good place for a young man to make a life." Before becoming a Trooper, he was a firefighter for the Bureau of Land Management and a loadmaster for the C-130 cargo planes hauling equipment to the Alaskan oil fields. "I took a big pay cut to become an Alaska State Trooper, but I wanted a career in public service," he explains. Still committed to serving his community, he organized and leads the Patriot Guard Riders, is 1st Vice Commander of the American Legion Madera Post and serves on our HOA Board and Hospitality Committee.

Assigned to the Alaska Bureau of Investigation's Major Crimes Section, Sam spent most of his career in the Fairbanks office, which handles all major crimes in a 300,000 square mile area of Northern Alaska.

"In Alaska, the Trooper Investigator does it all. He's the deputy coroner, collects evidence, conducts interviews, does fingerprint checks, makes arrests and testifies at trial. I liked handling all the details of a case from start to finish."

Reflecting on the positives and negatives of his job, Sam says, "I found satisfaction in taking a criminal off the streets and preventing him from victimizing another person. But the downside was knowing I couldn't remove the trauma of the crime that the victim endured. During an investigation, you become intensely involved with the victims and their families. Seeing their pain is hard to take and you have to develop a certain distance in dealing with it."

Alaska's geography presents some unique challenges, and Sam became an expert in wilderness survival. He recalls a particular search and body recovery mission. "A passing helicopter flew me into a remote area with my sleeping bag, tent, some food and a smoke flare. The only way I could get back was to flag down a passing plane on one of the regular flyways. I told the pilot when he landed 'I am a State Trooper and I am commandeering this aircraft to take me and this body back to Fairbanks.' That was not well received."

Once, while snowshoeing across a pass in the Chugach Mountains on a training mission with two other Troopers, Sam heard a "whump" and looked up to see a wave of snow descending on him. The avalanche moved him about 200 yards. "I was in a world of white and couldn't breathe. So, I just did what I had to do to stay alive." It took him two hours to dig himself out, and his only injury was a strained arm from the digging.

Geography wasn't the only challenge. "A lot of people move to Alaska to get away from rules. They think it's a good place to hide. Alaskans are very independent and want to be left alone. That makes the Trooper's job tough because you need to get their trust before they will even talk to you."

Sam remembers having to interview a man who reportedly lived in a hole in the ground. Arriving at the man's cabin, he indeed found the man in a hole out back. The man claimed radio waves would get in his head and make him crazy if he came out of the hole. Sam devised an ingenious solution. He made a hat out of tin foil and told the man, "I have the same problem, but when I wear this hat the radio waves don't bother me. Want to try it?" The man tried it and said, "Hey, it works." Sam then drove him to headquarters, both of them wearing their tin foil hats. "He may still be wearing that hat today," Sam laughs.

Giving new meaning to the expression "a tough day at the office," a highlight of Sam's

career was solving the serial murder of five young girls in the Fairbanks area. The FBI developed a profile of the killer, giving Sam 5,000 possible suspects to investigate. A break came when the murders stopped for a year after having escalated, leading Sam to think the killer may have moved away. He succeeded in tracking down a suspect to a town in Texas. "The guy was pretty cagey, so we needed a plan. We set up a phony Trooper office in Texas, complete with empty filing cabinets, and walls covered with pictures of the victims and charts relating to the investigation. When the suspect came in for questioning, he saw the pictures and finally confessed." In a shocking turn of events, the suspect was killed when his motorcycle plowed head on into a truck just moments before Troopers obtained an Alaska warrant for his arrest. "I wish I'd been able to ask him why he committed the murders," Sam says.

Sam was also Chief Investigator for Alaska's worst mass murder, which occurred in the small village of Manley Hot Springs. Tragically, and as a reminder that law enforcement officers put their lives on the line every day, a Trooper was killed during a gunfight while pursuing the killer from a helicopter. "When the helicopter came back to the remote landing strip with the Trooper's body still strapped into the seat, I had thoughts of quitting the Troopers. I had trained him to shoot from a moving helicopter and will always feel a responsibility. He was my friend."

It isn't surprising that Sam has received several commendations, including being named Young Law Enforcement Officer of the Year and Alaska State Trooper of the Year. But Sam merely shrugs at the thought he did anything extraordinary and says, "I was just doing the job the citizens of Alaska paid me to do."

In addition, Sam received the highest award given to a civilian volunteer at the council level by the Boy Scouts of America. The award recognizes community service through hard work, self sacrifice, dedication and many years of service. Perhaps it's the one award that sums Sam up the best.
