President's Message By Tom Cooke

The year 2010 will soon pass into history. As we look back over the year, however, we can find a record of solid accomplishments within Esperanza Estates.

One of the major achievements this past year was the refurbishment of our pool and spa interiors, and the replacement of the pool ladder and handrails in both, which was completed this past spring. Following that, and equally important, was the complete replacement of all of the 351 street light heads within our subdivision with a uniform style lamp and energy saving light bulbs.

But the year's work product was much more than these two items. Our Enhancement Team held their annual yard sale, followed by its 2010 EE Home Tour—both of which were wildly successful—and did preliminary work on one of its future projects, a community xeriscape garden. The Team also paid for beautiful new decorative tile work on our entrance monuments on Esperanza and Portillo.

Our Hospitality Committee put on a full schedule of monthly social events, including the always popular Hamburger Nites, pot luck dinners, and special event holiday parties, several with musical entertainment.

A new standing HOA committee, Bienvenidos a Esperanza, was formed to help newcomers become integrated into our community, with a welcoming luncheon and a program.

We appointed a new editor for the Periodico, who has added a number of new and interesting features to the publication.

We added a new Wi-Fi "hotspot" at the Ramada/pool area, to allow residents to use

their laptops and other internet devices at that location.

We expanded the weekly circulation of the Monday Morning Memo to 267 recipients, and went with a commercial service for its distribution.

HOA Board of Directors/ Election Facts

The Board of Directors consists of nine members elected at large to serve a term of three years. The By-laws allow for four officers: President, Vice-President, Secretary and Treasurer. These officers shall be elected annually by the Board of Directors.

The members serve without compensation. The Board may elect such other officers as the affairs of the Association deem necessary.

There are two Committees required by the By-laws: an Architectural Control Committee which maintains the architectural integrity of the community; and a Nominating Committee to select nominees for the Board. This Committee shall make as many nominations as deemed necessary, but not less than the number of seats to be filled.

The Board can establish other committees as deemed necessary.

The Board can fill any vacancies by election at a general meeting.

No Board Member is personally liable for any action taken by the Association.

GV Community Coordinating Council

The meeting was held at the Desert Hills Center on Dec. 16th. Of significant note, GVCCC is now calling itself the Green Valley Council.

The President of the Chamber of Commerce wishes to make a statement to the Department of Homeland Security regarding the murder of the Border Patrol agent, so he wants the HOAs to send a letter. He will give us a letter telling us what to say. (Nothing like climbing on the band wagon.)

Traffic and Arroyos Committee tells us that the Continental Underpass is complete except for the stuff that isn't finished.

Health and Human Services Committee reports that Valley Assistance Services has a grant to implement a home inspection program with the GV Fire Department for purposes of fall prevention and fire prevention. This program is an important step in achieving a safer Green Valley. None of us is reaching new heights of agility these days. It was also pointed out that cooking related fires are the #1 cause of fires in GV. Perhaps a home inspection is worthwhile.

I have placed a flyer for the 4th Annual Volunteer Showcase on the Bulletin Board at the Ramada. The Showcase is being held at the West Center on 21 January from 2-4 p.m.

The Sheriff's Department says that the only increase in criminal activity in GV is in aggravated assault, so lighten up and cut down on red meat. The representative from Pima County Sherriff's Department (PCSD) also talked about the establishment of Quality of Life units to address issues that result from 911 calls. I believe that it would be worth our while to have someone from the PCSD talk at one of our HOA meetings.

I have also posted a flyer from the Pima Council on Aging on managing ongoing health

conditions. They hold seminars on health related issues that can affect our ability to live independently. The seminars will be held at the Valley Community Church in January on the 13th, 20th and 27th, and in February on the 3rd, 10th and 17th.

BRASS MONKEYS

Aviation Hall of Fame Pilot Lands in EE

From the first moments of her very first flight in her father's Aeronca Champ, EE resident Rosella Bjornson absolutely knew she wanted to be a pilot when she grew up. What she didn't know then was that years later she would make Canadian aviation history by becoming the first woman airline pilot in Canada and the first woman to become a first officer on a commercial jet aircraft in North America.

Rosella's earliest memory of flying is riding with her father in his small plane and playing with the controls. "As a child I was fascinated by how far you could see from a plane – you could see what was beyond the next hill, over the trees, and the higher you flew, the more you could see," she recalls. Her father had a grounded WWII twin-engine bomber, which became her playhouse, and her siblings and pets were her passengers.

Her chosen career path firmly in mind, Rosella earned her private pilot's license when she was 17 years old and her commercial license at age 19. Resolute in her determination to become an airline pilot, she built her flight hours as a flight instructor. Finally, in 1973, some of the pilots she had met told her about a job as a First Officer on an F-28 at TransAir, one of Canada's regional airlines at that time. She had been told many times that the airlines would never hire a woman pilot, but she applied anyway and was hired, thus becoming the first woman commercial airline pilot in Canada. "It was a dream come true."

Her excitement was somewhat tempered by the pressure of being the first woman airline pilot. "I knew I had to prove I was capable. Fortunately, my fellow pilots treated me with respect and as an equal. They didn't care much whether I was a man or a woman as long as I got the job done properly," she says.



Her fellow pilots accepted her, but others were surprised to see a woman pilot. Rosella remembers, with humor, the time she entered the women's restroom wearing her uniform. Thinking Rosella must be a man because she was wearing a pilot's uniform, the cleaning lady tried to chase her out of there.

Although her passengers were surprised, they thought it was great to see a woman pilot. "In the more than 30 years that I flew, only one male passenger changed flights when he found out there was a woman pilot."

There were additional challenges for the first woman pilot. When Rosella became pregnant with her first child, she applied for a medical leave of absence. Naturally, there was no precedent in the regulations to deal with a pregnant pilot, so the airline denied her request. Rosella was concerned that if she took a personal, rather than a medical, leave of absence, she would lose her seniority with the airlines. After considerable discussion with her employer, she ultimately agreed to take the personal leave so long as the airline guaranteed her seniority would not be impacted.

After her second pregnancy, however, Rosella complained about the regulations that would

not permit her to fly. Transport Canada held hearings and heard testimony from physicians on the issue. As a result of Rosella's efforts, a pregnant pilot is now allowed to fly while under her doctor's supervision.

Rosella's husband, Bill Pratt, is also an airline pilot and sometimes flew as her co-pilot on the Boeing 737. On these occasions, Bill took great delight in making cabin announcements saying, "Ladies and gentlemen, on behalf of my wife, the captain...." Rosella enjoyed working with Bill. "We always seemed to be on the same page and anticipated what to do next."

During her 31-year career, Rosella flew all the routes near the Arctic Circle in Northern Canada. Some of these required landing on gravel strips in remote locations. Rosella remembers a flight across the Arctic from Churchill to Yellowknife one cold, dark night in the middle of winter. "The sky was aglow with Northern Lights. It was like we were flying between ever-changing curtains of colored light. It was magnificent."

Being an airline pilot has its ups and downs. For Rosella, the opportunity to travel throughout North America was a real plus. But early morning check-ins and the semi-annual simulator testing and training sessions were not at all fun.

Rosella has received a number of prestigious awards, including the National Award of Achievement and the Manitoba Award of Achievement, which recognizes innovation and initiative in bringing positive and measurable improvements of significant and enduring benefit to transport in Canada.

In 1997, Rosella was inducted into Canada's Aviation Hall of Fame. "When I received the phone call, I thought they had made a mistake and should reconsider. The man who called had to convince me I had been chosen. It was an honor."

Now retired, Rosella continues to play an active role in the aviation community. Among other things, she is a member of the Board of Directors, Secretary, Treasurer and Administrator for Canada's Aviation Hall of Fame. When they are not in Esperanza Estates, Rosella and Bill live on an airpark in Alberta, Canada. Rosella flies a 1952 Cessna 170B. It's the very plane in which she learned to fly. She and Bill tracked it down and convinced the owner to sell it to them. A peek in their hangar will also reveal two vintage airplanes Bill is restoring and another that he is building. Maybe someday one will show up in their garage in Esperanza.

Their son has a pilot's license but would rather fix aircraft than fly them, so he is an aircraft maintenance engineer with a small airline in western Canada. Their daughter is an occupational therapist at a hospital in Alberta. Bill and Rosella are hopeful that their grandson will take an interest in flying Grandma's airplane, thus continuing the family flying tradition.

If a national, regional, or other emergency suddenly struck, would you be prepared to hole up for two weeks at home? A recent survey suggested that although many feel they would be just fine, only a small percentage actually had what the experts consider necessary in an emergency kit. It might be time for you to take an inventory, and see if you have on hand what you would likely need to get through such a period. One of the national research centers came up with the following as a basic list. Are you prepared?

Basic Necessities:

Nonprescription fever reducers and pain relievers Manual can opener

Sanitation and personal hygiene items First-aid kit including bandages, medical tape, antiseptics, etc.

A two weeks supply of any prescription drugs

Extra batteries

Thermometer

Hand sanitizer with at least 60% alcohol Portable crank or battery-operated radio Two week supply of nonperishable food Nonprescription diarrhea drugs Chemical cold packs

Electrolyte drinks (such as Gatorade)
Surgical masks with a rating of N-95 or higher
Two week supply of potable water for each
family member




